#### 1. 重要提示 / IMPORTANT NOTICE

本声明根据新西兰《2013 年金融市场行为法》(Financial Markets Conduct Act 2013) 及相关法规制定。在您(以下简称“客户”)通过 Wealth Insights Securities Limited (以下简称“本公司”, FSP 注册号: FSP1003463) 进行任何金融产品交易前, 请务必仔细阅读本声明。

#### 2. 总体投资风险 / GENERAL INVESTMENT RISK

本金损失风险 / Risk of Loss: 金融市场投资存在固有风险。证券、衍生品、外汇或其他金融产品的价格可升亦可跌。您可能会损失部分或全部初始投资资本。

Financial market investments involve inherent risks. Prices of securities, derivatives, or currencies can fluctuate. You may lose some or all of your initial investment.

#### 3. 杠杆与衍生品专属风险 / LEVERAGE AND DERIVATIVES RISK

高杠杆放大亏损 / Magnified Losses: 若您参与保证金、差价合约 (CFD) 或外汇交易, 请注意杠杆机制会同等放大您的收益与亏损。

If you trade on margin, CFDs, or Forex, leverage can magnify both profits and losses equally.

亏损超过初始资金 / Losses Exceeding Deposits: 在极端市场变动下, 您的亏损可能会迅速超过您存入的全部初始资金, 且您可能需要承担追加保证金的法律义务。

Under extreme market movements, your losses may quickly exceed your total initial deposits, and you may be legally required to pay additional margin calls.

#### 4. 市场与流动性风险 / MARKET AND LIQUIDITY RISK

市场波动 / Market Volatility: 由于全球经济、新西兰或国际政治、新西兰央行利率变动或突发地缘政治事件, 市场可能出现剧烈波动。

Markets can experience high volatility due to global economics, local/international politics, RBNZ interest rate shifts, or geopolitical events.

流动性限制 / Liquidity Constraints: 在某些市况下 (如开盘跳空、停牌、重大数据公布), 您可能无法以预期的合理价格或在预期时间内迅速平仓, 从而导致亏损扩大。

Under certain market conditions, you may face difficulties liquidating positions at a reasonable price, which could lead to wider losses.
